### ***Application for reproduction***

A third party intending to reproduce one or more small extracts of standards or normative documents according the fair practice principle, can apply for an authorization by completing the attached application form.

### ***Fair practice***

Fair practice consists in reproduction of small extracts for non-commercial educational and informational purposes following specific rules:

- small extracts are limited text, data, figures, tables, pictures or drawings and they shall not be fundamental or essential parts of the publication. Reproduced text shall not exceed 10% of the normative text (front pages, table of contents, etc. are excluded) of each individual source publication;
- non-commercial purposes are for example documents for promotion, review, comment, analysis and other similar educational or informational purposes;
- the extracts are not going to be made available on public Websites (accepted only on intranet or restricted access on the website via password/members account, etc.).

### ***Basic conditions for a publication with reproductions***

The basic conditions for the publication holding the reproductions are:

- the publication shall not resemble a BEC standard or other BEC publication. Therefore, the publication shall have a different layout and the title of the publication must indicate that this is not a standard or normative document;
- the declaration of the source for each reproduced text;
- the inclusion of a statement that the official BEC standards and BEC publications that are referenced are available at BEC;
- a copy of the publication in each available language needs to be provided to BEC.
